To make the arraignment process more efficient, I am requesting that defense counsel consider filing a written waiver of arraignment.

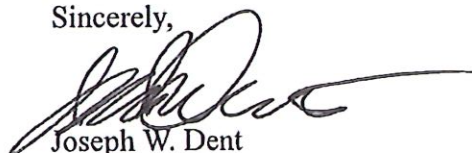

If a plea is negotiated, it may be entered after the calendar is called. If a formal arraignment is requested, it will also be conducted after the calendar is called.

Defendants, their counsel, and the prosecutors are expected to appear at the time and location stated herein unless a Waiver of Arraignment is filed. **Defendants for whom a "Waiver of Arraignment" is not filed, and who fail to appear, will be subject to arrest by a bench warrant.**
