APPEARANCES

All parties and counsel **MUST** appear on the above date and announce whether they are ready for trial or that a plea will be entered. For all cases announcing a plea will be entered, **GUILTY PLEAS WILL BE TAKEN IMMEDIATELY FOLLOWING THE CALL OF THE CALENDAR. FOR ANY DEFENDANTS IN JAIL, PLEAS WILL BE TAKEN AT THE DOUGHERTY COUNTY JAIL, 1302 EVELYN AVE., ALBANY, GEORGIA, AT 2:00 P.M. ON OCTOBER 5, 2026.**

PLEA OFFERS

Prosecutors who are assigned to the cases that appear on this Calendar shall serve plea offers, if the State chooses to make any, upon defendants' counsel **IMMEDIATELY**.

PLEA DOCUMENTS/PAPERWORK

If the State and Defense counsel reach an agreement on a plea, defense counsel shall notify Judge Dent's Judicial Assistant, Maria Henley, of the plea agreement. Counsel shall email the plea documents (Plea and Sentence Recommendation, Waiver and Acknowledgment of Rights, Plea of Defendant, Waiver of Recidivist Sentencing, Pretrial Intervention Agreement, and other applicable paperwork) to her at mhenley@dougherty.ga.us. **no later than 9:30 a.m. on Friday, October 2, 2026.**

TRIAL CALENDAR

In all cases in which counsel announces ready to proceed, said case will be placed on the calendar for the **two-week jury trial term** set to begin at **9:00 a.m. on Monday, October 12, 2026, in Courtroom 226** at the Dougherty County Courthouse, 225 Pine Avenue, Albany, GA 31701. **THE ORDER IN WHICH CASES WILL BE TRIED WILL BE SET AT THE CONCLUSION OF THE CALENDAR CALL, AND A TRIAL CALENDAR, WITH THE ORDER OF THE CASES, WILL BE ANNOUNCED AND SENT TO ALL PARTIES. ALL CASES WILL BE CALLED AT THE BEGINNING OF THE TWO-WEEK TRIAL TERM AND WILL BE TRIED IN THE ORDER IN WHICH THE CASES APPEAR ON THE CALENDAR.** The trial term will continue the week of **October 19, 2026**. In all cases placed on the trial calendar, counsel shall proceed with trial upon two (2) hours' notice. For all cases in which counsel announces ready and which case is placed on the trial calendar, the following shall apply:

OBJECTIONS TO WRITINGS, AUDIO, AND VIDEOTAPES. All objections to any portion of any oral, written, audio, or videotaped statement or any document, chart, photographs, etc. **SHALL:**(a) Be made in writing; (b) Specifically identify where the material

objected to is located in the oral, written, audio or videotape by line, minute and second, or other coordinates indicating the beginning and ending; (c) State concisely the substance of the material objected to; and (d) Separately state the legal basis for each objection with supporting cites to relevant statutes and cases. Counsel shall serve a copy of the objections on opposing counsel and provide the Judge with a copy of the motion and writing, audio or videotaped statement, document, chart, photographs, etc., at least seven (7) days before the first day of the trial calendar. Objections that do not comply with these requirements shall be waived.

STIPULATIONS, EXHIBITS, ETC. At least seven (7) days before the first day of the trial calendar schedule above, counsel for the state and the defendant(s) shall exchange copies of the pre-marked exhibits each may seek to introduce during the trial and request the opposing counsel to stipulate to the authenticity and admissibility of each. All stipulations shall be reduced to writing, filed with the Clerk, and a copy provided to the Judge before the trial.

If counsel objects to or refuses to stipulate to particular exhibits, the objecting counsel shall put such objections in writing or file a motion in limine as to such evidence, state clearly the legal and factual basis for such objection or motion, serve the other party, and present the objections, motions in limine, etc. to the Judge for a ruling.

DIGITAL EXHIBITS. To reduce the handling of paper or physical evidence in the courtroom, counsel shall use digital exhibits whenever feasible. At least seven (7) days before the first day of the trial calendar, counsel who intends to present evidence in a digital format shall notify the opposing counsel of the exhibit(s) involved, the software platform to be used, and make the digital exhibits available for the opposing counsel to view before the trial.

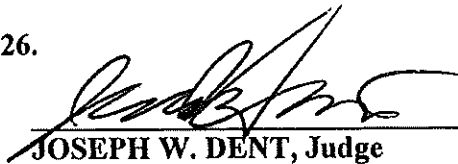
If counsel objects to the proposed introduction of digital evidence, the objecting counsel shall put such objections in writing or file a motion in limine as to such evidence, as to such evidence, state clearly the legal and factual basis for such objection or motion, serve the other party, and present the objections, motions in limine, etc. to the Judge for a ruling.

PANEL VOIR DIRE. Counsel shall notify the Judge in writing at or before the trial if counsel requests to voir dire the array in panels of 12, so that the Judge can instruct jurors to report at staggered times.

JUROR QUESTIONNAIRES, ETC. Counsel shall serve upon opposing counsel and the Judge at least seven (7) days before the first day of the trial calendar, a copy of any questionnaire or a list of any voir dire questions that counsel requests the Judge to ask members of the array.

DISCOVERY ISSUES. All issues and/or disputes regarding discovery shall be brought to the Judge's attention at least seven (7) days before the first day of the trial calendar. If a party has a pending motion to compel discovery, the Judge shall hear it before trial. Unless otherwise agreed or approved by the Judge, any discovery, evidence, and any witnesses not disclosed at least seven (7) days before the first day of the trial calendar.
